CERTIFICATE OF AMENDMENT TO THE AMENDED AND RESTATED DECLARATION OF RESTRICTIONS FOR LAKESIDE GREEN II-B HOMEOWNERS ASSOCIATION, INC.

WHEREAS in compliance with the requirements of the Declaration, at least a majority of the Board of Directors and a majority of the voting interests of the membership, in person or by proxy, have approved adding a new Article 5.12 to the Declaration:

Capital Contribution. Within 30 days after the transfer of ownership of a Unit, including record ownership transfers by deed, certificate of title, tax deeds, and other conveyances and transfers of the ownership of entities owning Units, a Capital Contribution in the amount of the greater of (1) \$1,000.00 or (2) two installments of the then annual regular assessment shall be due from the Unit Owner. The Capital Contribution shall be (a) deposited to the operating or reserve accounts, and (b) deemed and collectible as an assessment but is in addition to other regular assessments.
