## CERTIFICATE OF AMENDMENT TO THE AMENDED AND RESTATED ARTICLES OF INCORPORATION OF FOREST GROVE POA, INC.

THIS CERTIFICATE OF AMENDMENT is executed this <u>20</u> day of March, 2017, by FOREST GROVE POA, INC., a Florida not-for-profit corporation, (hereinafter referred to as the "Association").

## **RECITALS**

WHEREAS, the Association has been established for the operation of Forest Grove Patio Homes at Indian Springs, in accordance with the Amended and Restated Declaration of Maintenance Covenants for Forest Grove Patio Homes at Indian Springs ("Declaration"), the Association's Amended and Restated Articles of Incorporation ("Articles") and Amended and Restated By-Laws ("By-Laws") and related documents which were recorded on April 1, 2014, in Official Records Book 26700 at Page 0393 of the Public Records of Palm Beach County, Florida, and all exhibits and amendments

WHEREAS, pursuant to Article VIII of the Association's Articles, at a duly noticed meeting of the Board of Directors of the Association held on March 20, 2017, the proposed amendment to the Articles was approved by a majority of the directors.

NOW THEREFORE, Forest Grove POA, Inc. does hereby state as follows:

   Deleted language is indicated by <u>struck through</u> type.
- Section 1 of Article V of the Articles, entitled "Board of Directors", is hereby amended as follows:

Section 1. Board of Directors as Association's Governing Body.

The affairs of the Association shall be governed by a Board of Directors consisting of five (5) members. Only Members

and their spouse are eligible to serve on the Board of Directors.

All other sections of the Articles and the By-Laws remain unchanged.
