SECOND AMENDMENT TO DECLARATION OF CONDOMINIUM FORVILLAGE AT SWINTON SQUARE CONDOMINIUM

THIS SECOND AMENDMENT TO DECLARATION OF CONDOMINIUM FOR VILLAGE AT SWINTON SQUARE CONDOMINIUM (this "Second Amendment") is made by Lennar Homes, LLC, a Florida limited liability company, formerly known as Lennar Homes, Inc., a Florida corporation ("Lennar").

RECITALS

- A. That certain Declaration of Condominium for Village at Swinton Square Condominium was recorded in Official Records Book 21092, Page 1542, of the Public Records of Palm Beach County, Florida (the "Original Declaration").
- B. The Original Declaration was amended by that First Amendment to Declaration of Condominium for Village at Swinton Square Condominium recorded in Official Records Book 21164, Page 0182, of the Public Records of Palm Beach County, Florida (the "First Amendment").
- C. Section 6.2 of the Declaration provides that, as long as Developer is offering one (1) or more Units in the Village at Swinton Square Condominium (the "<u>Condominium</u>") for sale in the ordinary course of business, Developer shall have an absolute right to make any amendment to this Declaration. Developer is offering one (1) or more Units in the Condominium for sale in the ordinary course of business.

NOW THEREFORE, Lennar hereby declares that every portion of the Condominium is to be held, transferred, sold, conveyed, used and occupied subject to the covenants, conditions and restrictions hereinafter set forth.

- 1. <u>Recitals</u>. The foregoing Recitals are true and correct and are incorporated into and form a part of this Second Amendment.
- 2. <u>Conflicts</u>. In the event that there is a conflict between this Second Amendment and the Original Declaration and First Amendment, this Second Amendment shall control. Whenever possible, this Second Amendment, the Original Declaration and First Amendment shall be construed as a single document. Except as modified hereby, the Original Declaration shall remain in full force and effect.
- 3. <u>Definitions</u>. All initially capitalized terms not defined herein shall have the meanings set forth in the Declaration, except that the defined terms are hereby modified as follows:

"<u>Declaration</u>" shall mean the Original Declaration, the First Amendment and this Second Amendment together with all amendments and modifications thereof.

"Developer" means Lennar Homes, LLC, formerly known as Lennar Homes, Inc., its successors and such of its assigns as to which the rights of Developer hereunder are specifically assigned; provided however, a Unit Owner shall not solely by the purchase of a Condominium Parcel be deemed a successor to, or assignee of, the rights of Developer under this Declaration unless such Owner is specifically so designated as such successor to, or assignee of, such rights in the respective instrument of conveyance or any other instrument executed by Developer. Developer may assign only a portion of its rights hereunder, or all or a portion of such rights in connection with appropriate portions of the Condominium. In the event of such partial assignment, the assignee shall not be deemed Developer, but may exercise such rights of Developer specifically assigned to it. Any such assignment may be made on a non-exclusive basis.

4. <u>Site Plan Building Plan, Graphic Depiction of Improvements and Architect's Certificate.</u> The as-built building plans for building three (3) are attached as <u>Exhibit A</u> to this Second Amendment. All of the foregoing are hereby added to Exhibit 2 of the Declaration.

5. <u>Covenant</u> . This second Ame	endment shall be a covenant running with the land.
