AMENDMENTS TO RECODIFIED RESTRICTIVE COVENANTS AND RESERVATIONS ("DECLARATION") and BY-LAWS ("BYLAWS") FOR ANTIQUERS AERODROME, INC.

Proposed Amendment to Article IV, Section E of the Declaration

(new text is underlined and deleted text is stricken through)

E. With the consent (which may either be obtained in writing at any time by written consent pursuant to Section 607.0704, Fla. Stat., or by voice vote, show of hands, or ballot at a duly called meeting of the membership of Antiquers Aerodrome, Inc.) of not less than a majority of the lots at ANTIQUERS AERODROME with the shareholders of Antiquers Aerodrome, Inc. casting only one vote for each lot regardless of how many individuals or entities own any particular lot. Notwithstanding the foregoing, the approval of greater than sixty (60%) percent of the lots will be required for any capital project of greater than One Million and no/100 (\$1,000,000.00) Dollars.

Proposed Amendment to Section 3 of the Bylaws

3. The annual meeting of the shareholders shall be held on the first Sunday of November each year, if not a legal holiday and if a legal holiday then on the next Sunday following, at 2:00 p.m. a date to be determined by the Board of Directors, but in no event more than thirteen (13) months after the previous annual meeting was noticed (whether or not a quorum was attained); at which meeting they shall elect by plurality vote a Board of Directors and transact such other business as may properly be brought before the meeting.
