EXHIBIT "1"

AMENDMENTS TO THE BY-LAWS OF CASA DEL RIO CONDONINIUM ASSOCIATION, INC.

As used herein the following shall apply:

A. Words which are lined through with hyphens (---) indicate deletions from the present provisions of the By-Laws.

B. Words which are <u>underlined</u> indicate additions to the present provisions of the By-Laws.

The following Items 1 and 2 are proposed Amendments to the By-

Item 1. Article (4 to) of the By-Laws shall be amended to provide as follows:

b. <u>Nominations</u> A nominating committee of three (3) members shall be appointed by the board of directors not less than 30 days prior to the annual members' meeting.

- (1) The nominating committee shall nominate at least one candidate for each vacancy each-member of on the Board to be elected by the members of the Association.
- (2) Additional nominations may be made from the floor of the meeting.
- Item 2. Article 3(d) of the By-Laws shall be amended to provide as follows:
- d. Quorum. A quorum at member's meeting shall consist of persons entitled to cast a-majority of less than forty percent (40%) of the votes of the Association. The acts approved by a majority of the votes entitled to be case by the members present or represented by proxy at a meting at which a quorum is present shall constitute the acts of the members, except where approval by a greater number of members is required by the Declaration or these By-Laws. The joinder of a member in the action of a meeting by signing and concurring in the minutes thereof shall constitute the present of such member for the purpose of determining a quorum.
