CERTIFICATE OF AMENDMENT TO THE DECLARATION OF CONDOMINIUM FOR

SHEFFAELD WOODS AT WELLINGTON, A CONDOMINIUM

WHEREAS, at a duly called and noticed meeting of the membership of SHEFFIELD WOODS AT WELLINGTON CONDOMINIUM ASSOCIATION, INC. a Florida not for-profit corporation, held on May 18, 1988, the aforementioned Declaration, Articles of Incorporation and By-Laws were amended pursuant to the provisions of said Declaration, Articles of Incorporation and By-Laws.

NOW THEREFORE, the indersigned hereby certify that the following amendments to the occlaration, Articles of Incorporation and By-Laws is a true and correct copy of the amendments to the Declaration of Condominium, Articles of Incorporation and By-Laws as amended by the membership:

AMENDMENT TO ARTICES 16.8 OF THE DECLARATION OF CONDOMINIUM OF SHEFFIELD WOODS AT WELLINGTON, A CONDOMINIUM

16.2 PROPOSAL OF AMENDMENT. An amendment may be proposed by either a 75% vote of the entire Board of Directors of the Association, or by a 75% vote of the members at a duly called and noticed meeting. Directors and members not present in person or by proxy at a meeting considering the amendment, may express their approval in writing, provided such approval is delivered to the Secretary within ten (10) days after the meeting. Except as elsewhere provided, resolution adopting the proposed amendments must be approved by either:

ar-Not-less-than-75%-of-the-entire-membership-of-the-Board of-Birectors-and-by-not-less-than-75%-of-the-votes-of-the-entire membership-of-the-Association;-or

br--Not-less-than-90%-of-the-votes-of-the-entire-membership of-the-Association;-or

c--Until-the-first-election of a majority of the directors by the membership other than Sponsor as provided for in Article VIII-of-the-Articles of Incorporation, by all-of-the-directors

not less than seventy five percent (75%) of the members present at a meeting at which at least a quorum is present.

## AMENDMENT TO ARTICLE XIII OF THE ARTICLES OF INCORPORATION OF SHEFFIELD WOODS AT WELLINGTON CONDOMINIUM ASSOCIATION, INC.

3. VOTE NECESSARY FILING. In order for such amendment or amendments to become effective, the same must be approved by an affirmative vote of sixty-six-(66%)--percent-of-the-entire membership of the Board of Birectors and by an affirmative vote of the members having seventy five (75%)-percent of the votes of the entire membership of the Association not less than seventy-five (75%) percent of the members present at meeting at which at least a guorum is present. Such amendment or amendments shall be filed within ten (10) days from said approval, along with the appropriate filing fee.

Notwithstanding the foregoing provisions of this Article AIII, no amendment to these Articles may be adopted or become effective without the write written consent of Sponsor if it affects the rights of Sponsor or affects the Sponsor's ability to sell Units in the Condominium.

AMENDMENT TO SECTION 10.3 OF THE BY-LAWS OF

SHEFFIELD WOODS AT WELLINGTON CONDOMINIUM ASSOCIATION, INC.

10.3 VOTE NECESSARY; RECORDING. In order for such amendment or amendments to become effective, the same must be approved by an affirmative vote of 168-of-the-entire-membership of-the Board-and-by-an-affirmative rote-of-the-members-having-758-of-the votes-in-the-Association not less than seventy-five (75%) percent of the members present at a meeting at which at least a quorum is present. Thereupon, such amendment or amendments to these By-Laws shall be transcribed, certified by the President or Vice-President and Secretary of Assistant Secretary of the Association, and a copy thereof shall be recorded in the Public Records of Palm Beach County, Fortial, within ten (10) days from the date on which any amendment has been affirmatively approved by the Directors and the members.

10.4--PROVIGO:--Notwithstanding the foregoing-provision-of this-Article-10;-no-amendment-to-thete by Inwa-which-affects-the Sponsor-may-be-adopted-or-come-effective-without-the-prior written-consent-of-the-Sponsor.
