ARTICLE III. INSPECTION OF NEW BUSINESSES

Sec. 14-71. Applicability of article.

This article shall be applicable to the issuance of business tax receipts for the establishment or opening of new businesses within the town and shall not apply to the annual renewal of business tax receipts. (Ord. No. 67, § 5, 6-8-83; Ord. No. 162, § 6, 12-20-06)

Sec. 14-72. Penalty for violations of article.

Any person who violates, disobeys, omits, neglects or refuses to comply with or who resists the enforcement of any of the provisions of this article shall be subject to punishment as provided in section 1-14, or may be cited to the Town Code Enforcement Board. (Ord. No. 67, § 6, 6-8-83)
