ARTICLE IV

BOARD OF DIRECTORS: SELECTION: TERM OF OFFICE

Section 1. Number. The affairs of the ASSOCIATION shall be managed by a Board of Directors consisting of not less than ~~seven (7)~~ five (5) persons and no more than seven (7) persons who need to be members of the ASSOCIATION.

ARTICLE IV

BOARD OF DIRECTORS: SELECTION; TERM OF OFFICE

...

Section 2. Term of Office. Except for the first Board, all Directors shall be elected at each annual meeting of the members of the ASSOCIATION for the term of ~~one year~~ two (2) years on a staggered basis. The terms of the members of the Board of Directors shall be staggered. At the annual meeting in 2014, the three (3) candidates receiving the highest number of votes shall be elected for two (2) year terms. The two (2) candidates receiving the next highest votes shall be elected for one (1) year terms. Thereafter, all directors shall serve two (2) year terms. No change in the size of the Board shall serve to shorten the term of any Director. In the event that the Association members fail to obtain a quorum after at least two (2) consecutive years, at the first election after such occurrence, the terms of all Directors shall expire and the three (3) candidates receiving the greatest number of votes shall be elected for two (2) years terms, and two (2) Directors shall be elected for one (1) year terms, in order to set up a staggered service as called for herein. Thereafter, all Directors shall serve two (2) year terms.
