Whereas, article II C entitled "assessments", second sentence states

and, Whereas, article  $\Pi$  C entitled "assessments", third sentence

states as follows: "If an annual assessment is not made as required, an assessments shall be presumed to have been made in the amount of the last prior assessment and semi-annual installments on such assessment shall be due upon each installment payment date until changed by an amended assessment.'

and, Wheress, at the annual members' meeting held on December 2, 1974, a resolution to amend the second and third sentences of article WI C

was passed, unanimously, by the members to read as follows:
Article XI C second sentence is hereby amended to read: "Such assessments shall be due in four equal installments on the first days of January, April, July and October of the year which assessments are made.

Article VI C third sentence is hereby amended to read: "If an annual assessment is not made as required, an assessment shall be presumed to have been made in the amount of the last prior assessment and quarterly installments on such assessment shall be due upon each installment payment date until changed by an amended assess-
