

CERTIFICATE OF AMENDMENT TO
DECLARATION OF CONDOMINIUM OF
BOCA TEECA CONDOMINIUM NUMBER 9, INC.

WHEREAS, the Declaration of Condominium of Boca Teeca Number 9, Inc. was duly recorded in Official Records Book 3199 Page 1926 of the Public Records of Palm Beach County, Florida; and

WHEREAS, at a duly called and convened special meeting of the members of the Association held on July 3, 1982, the members voted on the following Amendment to the Declaration of Condominium:

1. Submission Statement

Paragraph 8: Common Expenses mean expenses for which the unit owners are liable to the corporation. Such expenses shall include the expenses incurred in the installation, operation and maintenance of a cable or satellite television transmission system servicing the condominium property.

WHEREAS, it is further certified that the Amendment set forth above received the affirmative vote of the owners of Condominium Number 9, as required by Article 5 of the Declaration of Condominium; and that thereby, in accordance with the pertinent provisions of said documents, the Amendment as herein set forth as stated verbatim in the Notice was adopted and approved as per the requirement of the applicable documentation and is accordingly effective upon the recording of the certificate as provided in Section 718.110 of the Florida Condominium Act.
