RULES AND REGULATIONS OF LA VIDA HOMEOWNERS ASSOCIATION, INC.

These Rules and Regulations of LA VIDA HOMEOWNERS ASSOCIATION, INC. are executed this <u>/2ra</u> day of <u>french</u>, 1994, by the Board of Directors of LA VIDA HOMEOWNERS ASSOCIATION, INC.

WHEREAS, The Board of Directors is granted the right to adopt such rules and regulations from time to time governing the use and enjoyment of the common area and the use of the lots as the Board deems appropriate or necessary pursuant to section 9.18 of the Declaration of Covenants, Conditions, Restrictions and Easements for LA VIDA; and

WHEREAS, Pursuant to paragraph 5.01(e) of the By-Laws of LA VIDA HOMEOWNERS ASSOCIATION, INC. the Board of Directors is granted power to adopt administrative rules and regulations and to amend such rules and regulations from time to time; and

WHEREAS, the Board of Directors is granted by Section 5.04(a) of the By-Laws of La Vida Homeowners Association, Inc. the right to adopt such reasonable Rules and Regulations as deemed advisable for the maintenance, conservation and beautification of the property and for the health, comfort, safety and general welfare of the owners; and

WHEREAS, a special meeting of the Board of Directors called by the President upon 48 hours notice in writing to each member was held on the <u>(ZIM</u> day of <u>Grid</u>, 1994; and

WHEREAS, The purpose of the meeting was to approve the passing of these Rules and Regulations.

NOW, THEREFORE, pursuant to the powers and authorities granted to the Board of Directors of LA VIDA HOMEOWNERS ASSOCIATION, INC., the following Rules and Regulations for LA VIDA HOMEOWNERS ASSOCIATION, INC., are hereby promulgated:

1. Each owner of a lot or dwelling shall provide the Board of Directors a copy of the lease signed by the Owner and the Tenant for the lot or dwelling. Such Lease shall include the name of all individuals to occupy the lot or dwelling pursuant to the Lease and shall include the agreement of the tenant to abide by the Declaration, the Articles of Incorporation, the By-Laws and Rules and Regulations of LA VIDA HOMEOWNERS ASSOCIATION, INC. and to provide for attorneys fees to the association for the purpose of enforcing the above described documents including eviction proceedings should they be necessary. A copy of the Lease shall be provided to the association prior to the Tenant taking possession of the premises. Failure to do so shall be a basis for the Association to seek eviction along with any other remedy appropriate under the circumstances.

2. Pursuant to the authority granted the Architectural Control Committee pursuant to Section 9.22 of the Declaration of Covenants, Conditions, Restrictions and Easements for LA VIDA to approve the exterior color of any dwelling, the Board of Directors does hereby adopt the proposal of the Architectural Control Committee for required colors for each dwelling including stucco, trim and garage door, front door and band as determined on the attached Exhibit "A". Unless specifically modified by the Architectural Control Committee, this list shall remain in full force and effect as the required colors for each lot and dwelling.

3. There is hereby instituted a fine of \$50.00 for breach of any of the covenants contained in the Declaration of Covenants, Conditions, Restrictions and Easements for LA VIDA, the Articles of Incorporation, the By-Laws or the Rules and Regulations. This fine shall apply to any breach including failure to pay timely the assessments as provided for by the association. This fine shall be in addition to the ability to assess a special assessment pursuant to Section 13.02 of the Declaration of Covenants, Conditions, Restrictions and Easements for LA VIDA.
