AMENDMENT TO BYLAWS OF MADISON GREEN MASTER ASSOCIATION, INC.

A Florida corporation not for profit (Additions shown by "underlining", deletions shown by "strikeout")

- 1. Section 13 of the Bylaws of Madison Green Master Association, Inc. entitled "Rules and Regulations" is amended and deleted in its entirety, as follows:
- Rules and Regulations. The Board may, from time to time, adopt, modify, amend or add 13. to the Rules concerning the use and operation of the Project., except that subsequent to the date control of the Board is turned over by the Developer to Owners other than Developer, Owners of a majority of the Dwelling Units represented at a meeting at which a quorum is present may overrule the Board with respect to the adoption or modification of any Rules. - Copies of such Rules shall be furnished by the Board to each affected Owner not less than thirty (30) days prior to the effective date thereof. At no time may any Rule be adopted which would prejudice the rights reserved to the Developer.
