- An extra cleaning of the clubhouse can be added onto the rental for \$200 and can be noted within the fee breakdown. This fee can be included in the rental fee check payment.

REQUIREMENTS AND RULES FOR USAGE OF THE CLUBHOUSE:

- 1. Payment of the rental fee and security deposit are required at the time of signing the rental agreement.
- 2. The only area that is available for use of a private rental is the interior of the clubhouse. The pool and pool deck are not able to be reserved for a private event or use.
 - As the pool/pool deck is not available to rent, in the event the pool/pool deck is utilized as the venue, or a part thereof, during the clubhouse rental, the owner will be charged an additional \$5,000 fee
- 3. Prior to gathering, a list of attendees must be provided to security to have access through the gate. This must be submitted at least 24 hours prior to gathering. Gate access is the responsibility of the owner.
- 4. No liquor may be served at the clubhouse or on HOA property.
- 5. No smoking is permitted in the clubhouse.
- 6. No loud noise or music is permitted at the clubhouse. Being mindful of neighbors and noise ordinances, any music or entertainment must be off by 11pm.
- 7. No swimming or gathering around the pool is permitted.
- 8. Residents and owners are not to be disturbed in any way as a result of the usage of space.
- 9. The Clubhouse is to be cleaned and trash properly disposed of at the end of the rental time. All lights should be turned off, doors locked, and all used furniture returned to storage closets.
- 10. Parking is permitted only in the spots that are marked guest parking. The owner is responsible for ensuring that their guests follow all community parking rules. Cars are not permitted to be parked along the entrance street in front of the clubhouse.
- 11. The maximum allotted time for rental/usage of the clubhouse is three consecutive days.
- 12. Children must be under the supervision of an adult at all times.
- 13. The Association and Management are not responsible for any accident or injury in any way.
- 14. All trash must be bagged and stored in existing trash cans at the clubhouse. The owner is responsible for taking the trash out on the trash day that follows their rental and returning the trash bin to the clubhouse after pick-up.
